

Engagement Officer Roles



- The **Point of contact** for supplier engagement access to the Supplier Readiness Programme.
- Community outreach to identify new businesses that are not already part of London public sector networks and registering them onto the programme.
- Offers tailored advice and introduces the supplier to a suite of support.
- Signposting to relevant training sessions and workshops.
- Facilitation of attendance at 'meet the buyer' events with the council and other public sector buyers.
- Provides **networking opportunities via events with large scale contractors** bidding for high value contracts with the council, so that they may be incorporated into our tier two supply chain
- Presents pipeline opportunities to relevant suppliers.
- Introduce **new, smaller and diverse suppliers within certain sectors to internal staff** who procure from those sectors, allowing them to pitch and showcase their products/ services.




- The Responsible Economy Team harnesses our relationships with employers and businesses to deliver impact and social value in our communities.
